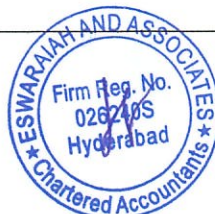



To The President,

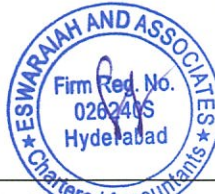
JANATA CONGRESS NATIONAL MOVEMENT PARTY
