

DECLARATION

Subject: 29C of Representation of peoples Act

Sir,

In this regard yours kind attention is invited to Section 29(C) of Representation of Act, 1951, which is reproduced as under -

Declaration of donation received by political parties

- 1. The Treasurer of the political party or any other person authorized by the political party in this behalf shall in each financial year, prepare report in respect of the following namely (a)the contribution in the excess of twenty five thousand rupees received by such political party from any person in that financial year.
 - (b) the contribution in the excess of twenty five thousand rupees received by such political party from companies other than government companies in that financial year.
- 2. The report under sub-section (1) shall be in such form as may be prescribed
- 3. The report for a financial year under sub-section (1) shall submitted by the treasurer of political party or person authorized by political party in this behalf before the due date of furnishing a return of that financial year under section 139 of the Income-Tax Act. 196 (43 of 1961) to the Election Commission.
- 4. Where the treasurer of any political party or person authorized by political party in this behalf fails to submit a report under sub-section (3), then, not withstanding anything contained in the Income-Tax Act, 1961(43 of 1961), such political party shall not be entitled to any relief under that Act.)

Above provisions are very clear as far as the submission of report in respect of the contribution is concerned. It is brought to your notice that in compliance of the said provisions we have already submitted Report of Contribution of the political party every without any violation.

Further it is also brought to your notice that in compliance of statutory provisions of Section 13-A of the Income Tax Act,1961 accounts of the political party is being audited and the Annual Audit Report / Annual Audited Accounts are being filed along with Income Tax Return with the Income tax department every year

Further it is also brought to your notice that in complying "guidance Note on Accounting & Auditing of Political Parties" issued by the Institute of Charted Accountants of India.

You will kindly appreciate that submission of Report of Contribution are covered by statutory provisions i.e. Section 29(C) of Representation of People Act,1951, as such ,unless there is an amendment carried out in the Act, the same cannot be modified or amended . In our earlier reply on Transparency Guidelines issued by the commission ,we have already submitted that the guidelines purported to have been issued under article 324 of the Constitution of India cannot over-ride the statutory provisions, as in fact the guidelines issued by the Commission is variance to statutory provisions, as such guidelines are not legally enforceable nor can be implemented until and unless amendments is carried out in the principal Act.

You will kindly appreciate that the Annual Audit Report / Annual Audited Report referred to in your letter is no requirement of section 29(C) of representative of People Act,1951 and we have been trying to impress upon the Commission that no action or step may be taken on the basis of guidelines which are contrary to the statutory provisions.

In view of position explained herein above, the said letter may be withdrawn and no further action may be taken in pursuant thereto.
